- Theory questions
- Practical demonstration 3 lifts, different load mass required
- Duration: maximum 4 hours per person

HRD offers the *TLIDO12* Operate a vehicle-mounted loading crane unit of competency as assessment-only in the workplace. Training is not provided.

Accredited training

- Statement of Attainment issued on successful completion of assessment.
- There are no formal prerequisites, but candidates must be 18+ vo.
- It's recommended that candidates complete dogman training to assist with load assessment and slinging knowledge and skills.

Confirm that your workforce has the skills and knowledge to set up and operate a vehicle-mounted loading crane (capacity less than 10 metre tonnes) safely in accordance with workplace requirements.

Operate a vehicle-mounted loading crane – < 10mt*

TLID0012 Operate a vehicle-mounted loading crane covers the skills and knowledge required to operate a vehicle-mounted loading crane to shift loads with a capacity of less than 10 metre tonnes.

What is a vehicle-mounted loading crane?

A vehicle-mounted loading crane is defined as a crane mounted on a vehicle for the principal purpose of loading and unloading the vehicle.

Skills and knowledge assessed

Skills and knowledge covered in the assessment include positioning and stabilising a vehicle-mounted crane, operating the crane and monitoring lift conditions, packing up the crane after operations, and completing required workplace records.

Entry requirements

Personnel wishing to undertake assessment in the operation of a vehicle-mounted loading crane need:

- to use and understand basic English
- a basic knowledge of Math
- to be a minimum of 18 years of age.

Recommended entry skills

Personnel undertaking assessment for this unit of competency will be required to know and be able to demonstrate the application of load estimation and slinging techniques to move a load.

Assessment candidates may find it useful to have completed dogging training prior to assessment.

Assessment

Assessment includes a theory component and practical demonstration of skills and knowledge.

A candidate is expected to complete 3 lifts of different load masses in 4 hours for this assessment.

RPL

Recognition of prior learning is available.

RPL may reduce the number of lifts required, but practical demonstration of at least one lift will still be required.

- HRD offers this unit of competency as assessment-only in the workplace. Training is not provided.
- Licencing requirements may vary from state to state. Candidates/employers should check their local jurisdiction
